# Contract Specifications

a) Ref Price A - Description	“ELECTRICITY-CAISO-SP15-DAY AHEAD” means that the price for a Pricing Date will be that day’s specified Price per MWh of electricity for delivery on the Delivery Date, stated in U.S. Dollars, published by the California ISO at <a href="http://oasis.caiso.com/mrioasis/logon.do">http://oasis.caiso.com/mrioasis/logon.do</a> , under the headings "Prices: Report: Interval Locational Marginal Prices: P/APNode ID: TH_SP15_GEN-APND" that reports prices effective on that Pricing Date.
b) Ref Price A - Pricing Date	Each day that prices are reported for the Delivery Date
c) Ref Price A - Specified Price	Average of LMPs for all hours ending 0700-2200 PPT
d) Ref Price A - Pricing calendar	CAISO
e) Ref Price A - Delivery Date	Contract Period
Final Payment Date	The fifth Clearing Organization business day following the Last Trading Day
