The purpose of this Circular is to inform Members and participants of revisions to volumes in the remaining auctions in 2022 for the auctioning of UK Allowances (UKAs) on ICE Futures Europe on behalf of the UK Department for Business, Energy, and Industrial Strategy.

The amendment represents an additional 803,500 allowances which shall be auctioned as surplus volume related to aircraft operators' free allocation entitlement. These additional allowances will be spread across auctions to the end of the year from and including the 21 September auction.
